### **Chairs Forward**

Things have continued to be very busy for FVP over the last year what with SEND work continuing and involvement with the restructure of CAMhs; working with Peterborough City Council (PCC), Cambridgeshire and Peterborough Foundation Trust (CPFT) and our Clinical Commissioning Group (CCG) enabling parental input at a strategic level. There are several ongoing work streams. FVP now have four employees which are required as a result of our continued growth. FVP is also delivering more training some in conjunction with CPFT. We have a bank of approved trainers that can deliver the Expert Parent Programme (EPP) and we have been commissioned to deliver this programme across Peterborough and Cambridgeshire. On the 12th April we moved to new premises with more space and better public transport links.

We held our fourth network event again at the Marriott Hotel this was attended by 120 people and was a successful evening raising £2300 on the night to be split with the years FVP chosen partners. FVP as a charity have always aimed to work jointly with other reputable organizations to ensure families who have children and young people with Disabilities and Complex Needs have information, advocacy, advice and support when needed.

As with previous years and in part due to how volunteering in particular being fairly transient there have been some changes to the volunteer team. The parent rep team has also seen some changes with parent carers having to carry out work that fits with their caring responsibilities. Some parent carers have maintained their involvement with FVP whilst others have gone on to gain paid employment and some have had to take a step back from involvement due to personal commitments related to caring for children/ young people with disabilities/ additional needs.

The parent representation work continues to grow and has this year seen parent reps facilitating focus groups as well as attending strategic meetings and task and finish groups relating to the Special Educational Needs and Disability (SEND) Reforms.

Through grant funding there has been an increase in the number of staff employed by the charity. The staffing of the charity is in relation to participation and the administration.

Taking on staff as well as facilitating the increasing work of the charity/ forum does lead to potential risks associated with becoming employers which the trustees will continue to mitigate through suitable financial planning, employee support and trustee board development.

# **Social Impact**

Definition: The effect of an activity on the social and/or environmental factors of the community (individuals and families) in which it takes place. Social impact is also about changes which improve people's lives and have positive consequences for the wider community.

### Outcomes/ Impact defined by some of our donors/ funders:

- Increased levels of employment or volunteering
- Reduced isolation or social inclusion
- Improved community cohesion and interactions
- Parents and Carers are empowered to participate in engagement activities with the Local Authority and their partners through representation activity
- Parents and Carers are empowered to engage with the Local Authority and their partners
- Training and Development so Parent carers have increased skills, knowledge to facilitate self-help
- Increased confidence from parent carers in managing behaviours that challenge associated with possible ASD/ ADHD (More specific impact)
- Parents and Carers are empowered engage with Local health providers and confident in understanding how to get the best from health services

### For FVP the social impact of the charity relates to activities that result in:

- Improved services for children/ young people with disabilities and additional needs,
- Increased parent participation which can include involvement, engagement, information sharing,
- Increased empowerment of parent carers leading to more involvement in the services accessed by their children and increased confidence.
- Increased employment including volunteering,

### Measuring Social Impact

FVP utilise a variety of qualitative and quantitative data to measure the outcomes and impact of the work of the charity; examples of the measurement methods include case studies, activity/ event feedback, survey results, quotes, numbers in attendance, demographic information, changes to services for children/ young people with disabilities through a "you said – we did" approach from the Local Authority.

- 1. FVP have seen two parent carers who spent time taking training courses and volunteering with the charity move towards employment with FVP. The parents fed back that through their time with FVP they gained confidence and felt more empowered and ready to move towards new ventures.
- 2. Services accessed by children and young people with special educational needs and disabilities have been co-produced by parent carers from parent representation and participation through to consultation. EHC processes and documentation, The Local

- Offer and CAMHs are areas that have had parent carer input. In the past year 133 parents in total have been involved at some level via face to face meetings/ events/ activities (unique attendance)
- 3. Through training and workshops parent carers have been supported to gain understanding of specific conditions; gained confidence in managing their children's needs and reported increased positive relationships with the health sector.
- 4. The trips, activities and parent carer sessions lead to self-reporting of increased well-being, new friendships being formed, and the opportunity to spend time with other people leading to less isolation.

# **Public Benefit**

For FVP the purpose of the charity is "To relieve the charitable needs of disabled children and children with complex needs and their families and carers in Peterborough in such ways as the trustees shall think fit, in particular by the provision of advice, information, support and advocacy" In this instance the beneficiaries of the charity are families and carers in Peteborough who have children complex needs and disabilities. Any work conducted by the board of trustees is for the benefit of this section of the public.

FVP conduct work relating to information, support, advice and advocacy through signposting, training, short breaks, collective advocacy, enabling parent carers to co-produce services for children with complex needs and disabilities. Much of the work listed in this report and especially in the social impact section above refers to how the trustees seek to meet the public benefit of the charity.

# Trips, Family Activity Days & Parent Carer Sessions

# **Coach Trips**

FVP ran one coach trip in the financial year 2015/16 which was funded through monies raised for parent carer and family based activities. A trip took place in September to Hunstanton and was attended by 16 families. The children's needs ranged from ASD to Hearing Impairment and their ages ranged from 2 to 23.

### **Local Family Based Activities**

- Halloween Party attended by 28 families (37 adults and 59 children) The children's needs ranged from Genetic Conditions to ASD and they were aged between 4 and 16
- Christmas Party attended by 23 families. The children's needs ranged from GDD to FASD and ages were from 3 months to 24 years
- FVP facilitated access to local family based amenities through a mixture of grant funding and donations.

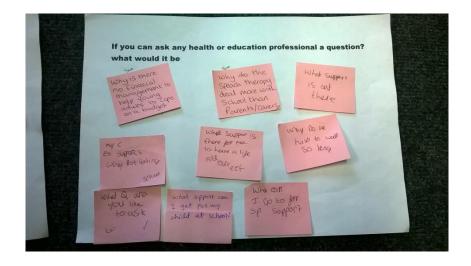

# **Caravan**















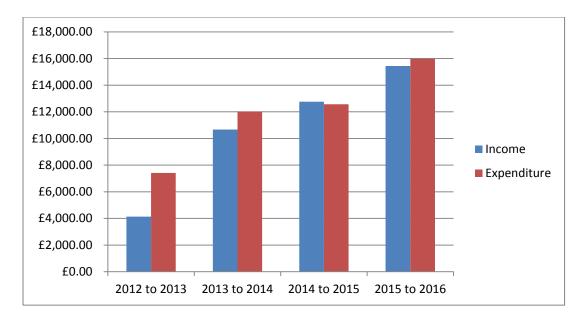
### **Management and Structure**

FVP trustees own and manage the caravans on behalf of the charity with the current chairperson and secretary being named as owners (holding trustees) on contracts with Butlins and Haven due to the charity itself being unable to own/lease property or sign contracts. The choice of trustees was in part based on prior caravan ownership experience and time and capacity to be able to attend the caravans to carry out required works.

### **Finances and Sustainability**

Expenditure was very high in 2012 to 2013 due to repairs, a complete re-stock and extra cleaning; this was in part covered by a grant and use of unrestricted funds. Income was generated through fees charged for use of the caravan.

There was an increase in income in 2013/2014 as it was the first full season running the Butlins caravan and the caravan was hired (sub-let) during all school breaks and a small number of donations were received towards running costs. There was also a slight increase due to take some bookings towards the end of the season in 2014 for the newly owned Haven caravan. Expenditure was again high due to having to not only cover running costs but also replace all the mattresses with waterproof mattresses and all the bedding in the Butlins caravan. These were replaced for hygiene reasons and due to damage sustained.

There was an increase in income in 2014/2015 due to FVP now taking bookings across two caravans for a full season. Expenditure only increased slightly and is based on running costs of both the caravans. It takes approximately £6,500 per caravan to cover running costs.

It took three years to put the caravan finances in a stable position where the accounts were in the black at the financial year end 2015. For the financial year end 2016 the accounts are in the red again. This is due to having to a high level of repairs across both caravans and havint to replace all bedding across both caravans; also the bedding in the Butlins caravan has been replaced with high quality waterproof bedding. The bedding in the Butlins caravan has needed to be replaced with such bedding to the state it has been left in consistently at the end of each season. The bedding in the Haven caravan has been replaced for the first time; the cleaner for this caravan also supplies FVP with a laundry service.

To make the caravans a viable venture and ensure sustainability charging for their use had to be introduced at a level that would at a minimum cover running costs. Costs have been kept at about 40% to 45% less that Butlins/ Haven would charge for hiring the same grade caravan. Families also save money with FVP as wristbands/ privilege passes are provided for free.

FVP also stock the caravans with a selection of DVD's, games and children activities (colouring books, puzzle books, crayons)

### Financial Management

To ensure appropriate financial management and separation from other FVP functions as a parent's forum the caravan funds are held in a separate bank account; the sole use of which is for the caravans.

### **Operating Procedures**

FVP have developed a caravan policy to enable the trustees to best govern the use of the caravans and this is informed in part by a set of operating procedures to cover day to day management of the caravans. People can hire the caravan and this means entering into a subletting/ holiday booking contract with FVP. The secretary to the board of trustees is the named person on the contract; this trustee is also a holding trustee for the caravans.

FVP have also developed a volunteer role description for anyone wishing to volunteer in supporting FVP in managing the caravan bookings. The management of the caravans can be time consuming especially in peak season.

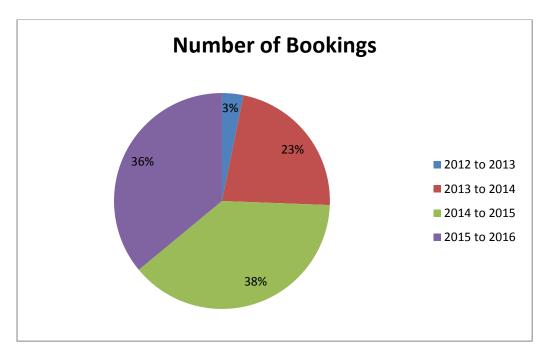
To hire the caravans, people complete a contract; pay a refundable damages deposit and fee. The caravan can be booked for three, four or seven night breaks with check-in and check-out days being Monday's or Friday's. The most popular choice is Monday to Friday four night breaks apart from the summer break where families prefer Friday to Friday seven night breaks

### **Bookings**

Season runs from March to October at both sites but much of March and September are given over to adult only weekends at Butlins.

The four bookings in 2012 to 2013 were confirmed by Butlins and before FVP took over ownership. Year two saw approximately 28 bookings of the caravans with about five of these being in the haven caravan between September and October and in year three there were 48 bookings across both caravans. In 2015 to 2016 across both caravans in a full season there were 45 bookings. Over the past four years there have been a total of 125 bookings and accounting for a small number of families who have booked more than one short break at least 110 individual families have benefitted from the caravan use.

# **Training**

FVP have worked on various training projects this financial year including:

- Parent Participation and Representation (HTRG)
- Parent Participation and Representation (Training for Trainers)
- Microsoft Basics (HTRG)
- Expert Parent Programme (EPP) CAMHs Transformation Funded
- Expert Parent Programme (Training for Trainers)
- Understanding Behaviours that Challenge
- Understanding ASD
- Understanding ADHD

The above training courses/ workshops have resulted in:

- Two parents have gained Microsoft basics skills which have helped in their volunteering (HTRG)
- 15 Parent carers from HTRG completing the EPP
- 19 parent carers attending the EPP CAMHs Transformation funded sessions and nine going on to be approved as trainers in the EPP
- Joint working with Pinpoint (Charity/ Parents Forum) for Cambridgeshire
- 74 parent carers attending and report positive outcomes from the understanding conditions workshops

# **Participation**

The participation work of the charity over the past year has seen a drop in some areas and an increase in others. The overall numbers engaging has decreased but the number of parent carers engaging in more than one area has increased. Much work in 2014 to 2015 concentrated on what was termed the SEND reforms especially leading up to the introduction of new legislation in September 2014 (Children and Families Act 2014). The changes to services relating to Special Educational Needs were some of the largest seen for 30 years and placed a strong emphasis on participation. Since April 2015 work has moved away from general engagement and information sharing to embedding the changes so the opportunities for participation have changed accordingly with much more focussed topic specific work.

Over the past year FVP has seen an increase in participation from parent carers from seldom heard groups which has been facilitated through a comic relief grant funded project called the "Hard to Reach Group (HTRG". This work combined with the ongoing Peterborough City Council (PCC) and Department for Education (DfE) grant funded participation work of the charity has resulted in a more diverse group of parent representatives being trained and subsequently attending strategic meetings.

The SEND reform work has decreased as service changes more from design and development to delivery so the level of participation in these areas has also decreased. There has been a high level of co-production at the design stage with a move to more general and individual participation at the delivery stage. This applies to areas such as Education, Health and Care plans; FVP co-produced the documentation and processes locally at the start so participation was high in terms of collective involvement. Once systems and documentation were in place the need for such collective participation decreased. From here there was much more emphasis on individual parent carers being involved in the development of their own children/ young person's plans.

### **Parent Participation Data**

- Parents have self-reported being members / attendees at local groups Peterborough
  District Deaf Children Society (PDDCS), Peterborough Area Down Syndrome Group
  (PADSG), Little Miracles (LM), National Autistic Society Peterborough Branch
  (NAS), Aiming High Group (AHG) and Shine
- Children's / Young people's disabilities have been reported by parents as including
  Autistic Spectrum Disorders, Learning Disabilities, Tourette's, Mental Health
  Disorders, Cerebral Palsy, Hearing Impairment, Down Syndrome, Complex Health
  Needs, Genetic Disorders, Duchene's Muscular Dystrophy, Marfans with an increase
  in health/ genetic disorders being reported.

- Those parents involved have self-reported ethnicity as White British, Pakistani, Portuguese, Albanian, Dutch, Chinese, Afghanistan, Ukrainian, Mixed White British, Canadian, Belgian and Gambian which is an increase on diversity
- Involvement from fathers is much lower than involvement from mothers and tends to be via open meetings / conference
- Reported age of children ranges from 2 to 25
- Methods used include open meetings, a conference, focus groups, on-line surveys, feedback and questionnaires at family based activities and parent representation
- Evidence is both qualitative and quantitative
- Co-production on; EHC plan templates (now new version), Local Offer ongoing development and professionals event, 0 to 25 steering group, CAMHs Transformation and funding discussions.

# **Fundraising**

Through a variety of fundraising methods FVP raised approximately £10,000 over the course of the financial year; some of this was designated for example where it was through joint events and intended for other organisations or where stipulations of use had been added such as to provide trips.

#### **Donations**

A generous donation of £1500 was received from The Rudolf Fund which was used to book two adapted coaches to run family based trips to Hunstanton and Robin Hood Festival in 2016.

#### **Fetes and Festivals**

As in 2014 FVP attended Bretton Festival where approximately £250 was raised on a tombola and sand art; the tombola sold out before the end of the day and we are grateful for all the generous donations towards the tombola.

# **Network Event and Participation Awards 4th December 2015**

FVP hosted the fourth FVP Network Event and the Third Participation Awards on the 4<sup>th</sup> December 2015. The event took place at The Marriot with approximately 120 people in attendance. As in the previous year there was a Community Supporter, Volunteer and Local Authority Partner award. Just over £2300 was raised on the night through the Auction and Raffle; this would not have been achieved without the hard work of Mrs Jenny O'doherty who volunteered her time to put the auction and raffle together and spent time seeking support from businesses in the local community. As with previous years the portion raised for FVP will go towards covering costs from running the caravans to further enable low costs short breaks to be provided to families in need. A special thank-you must go to our host for the evening Andy Burrows, funny and entertaining as always and we look forward to working with him on the next event.

### **Joint Fundraising**

Joint fundraising took place at the Network Dinner mentioned above and monies were raised for Families First Peterborough and Heltwate School.

# **Fundraising Support**

We are also exremely pleased to have been chosen by Ferguson Financial as their nominated charity and will continue our partnership in to 2016. We are grateful for their support and they have also supported with the move to the new premises.

# **Treasurers Report**

As in the previous year FVP have seen an increase in grant funded income this financial year which has had an impact on the accounts overall; As with previous years FVP have received funding for the next financial year in this financial year period. This means funding for 2017 to 2018 is already with the charity and was paid in March 2016; which is specific to SEND related work. FVP have also been paid funding for engagement with seldom heard groups (parent carers) for 2016 to 2017 in March 2016. This income when paid early is ring fenced for the designated financial year.

There is a deficit in relation to the funding intended for 2016 to 2017 as some of this had to be used to cover a project totalling £19.1K relating to CAMHs transformation and parent carer engagement and support. The funding for the 19.1K will be paid to FVP in the 2016 to 2017 financial year by PCC. The payment will be late due to commissioning issues relating to carrying out work for the LA and Health sector.

The DfE grant that FVP receive as the designated Parents Forum for Peterborough has been higher than usual due to extra payments termed "extraordinary discretionary, discretionary and further discretionary grants. The total grant income in this area has been £20,847

There has been an increase in expenditure in relation to "utilities, insurance, staffing, premises costs due to increased staffing levels and a move to new premises.

Staffing is fully grant funded and at the end of the financial year there is a liability to the charity for covering of salaries in April 2016 for contracted work periods of April 2015 to April 2016

### <u>Treasurers Report - Caravan Accounts</u>

There has been an increase in income for the two caravans in part due to 2015 to 2016 being the first full season that both were available. Income is designated as it is used to cover the caravan running costs. Also a portion of the income in the account is generally refunded to the families who use the caravans as it is refundable security deposits for secure breaks. As of 31<sup>st</sup> March 2016 the caravan account ended in the black but £1,200 of the closing balance is refundable security deposits.

The biggest unplanned expenditure has been replacement bedding and emergency repairs.

### **Financial Reporting**

In October 2015 discrepancies in expense claims from a member of the board of trustees over a period of 4 months were discovered after an examination of the accounts. As soon as this was discovered it was internally investigated followed by an external examination by Peterborough Council for Voluntary Services. A report was produced confirming and detailing the discrepancies. Some guidance was sought as to what procedure to follow and the charity commission were informed. The relevant grant funders to whom the monies related were contacted and they were given an explanation of what had occurred and what had been carried out as a response.

After receiving the independent report and examination of all expenses the FVP Board of Trustees brought in external training looking at policies, procedures and what is meant by being a trustee on a charity. The expenses claims investigation and led to a change in the board of trustees and the subsequent training for the board also resulted in a further change. The payment policy, claim forms and mileage claim forms have since been altered, instead of having one signature to sign off the expense claim; it will be two signatories with at least one being a trustee. There is also a plan being developed to recruit to the board trustees who have particular skill sets and can add extra support to the further development of the charity.

### RESERVES STATEMENT

The trustees worked to establish sustainability and good governance for the charity and have developed various policies and procedures and one such policy under development is a reserves policy. The policy will establish how reserves levels are set and how these relate to unrestricted funds and such levels will be managed.

Although funds for the caravan are unrestricted they have been considered as designated and therefore not to be included in the free reserves of the charity as they are necessary to ensure the continued sustainability of the caravans to ensure ongoing short break provision.

The trustees propose to maintain the charity's free reserves at a level which is at least equivalent to six months operational expenditure going forward. This has not been achieved yet and has risks around holding low reserves have been acknowledged. The charity currently has an equivalent of two months free reserves and work is taking place to increase the level of free reserves. This will need balancing against the high level of grant income and expenditure which is restricted.
